# **Summary of Rules and Regulations**

#### RULES

All persons must adhere to the Rules and Regulations of the Sandusky County Park District & the laws of the State of Ohio and comply with all the orders of Law Enforcement.

## ALCOHOL (529.01)

Alcoholic beverages are prohibited within all areas of the parks.

## **ANIMAL EXCREMENT REMOVAL (505.03)**

Owner or custodian must immediately remove excrement deposited by such animal. Disposal of excrement is to be placed in any litter receptacle or in a sanitary manner.

#### **CAMPING AREAS (749.03)**

Camping is permitted in designated areas only and is subject to the rules and regulations posted at that particular site.

## **CAMPGROUND GENERATORS (749.04BB)**

All generators are prohibited in the campgrounds.

#### **CANOPY OR SUN SHADES (755.07)**

Personal umbrellas less than 48" in diameter are allowed, must be at least 2 feet behind lifeguard chairs.

No easy-ups or canopy style tents.

#### **CRIMINAL TRESPASS (541.07)**

Unauthorized access or presence without proper permit shall be considered trespassing.

#### **DISORDERLY CONDUCT; INTOXICATION (509.01)**

No person shall recklessly cause inconvenience, annoyance or alarm to another.

## DRUG ABUSE; CONTROLLED SUBSTANCE POSSESSION OR USE (513.03)

No person shall knowingly obtain, possess or use a controlled substance or a controlled substance analog.

#### **FIREARMS (549.03)**

Discharge of Firearms, Weapons, Explosives, etc. is prohibited, other than in authorized permitted hunting areas, special programs, or authorized demonstrations. No person except Law Enforcement Officers, shall discharge or cause to discharge any firearms, weapons, explosives, fireworks or other dangerous weapon within or adjacent to the Parks without specific written permit from the Director.

## FIRES (751.01)

Small fires are permitted only in park grills, privately owned grills and fire rings provided for that purpose.

## **GLASS, METAL CONTAINER AND COOLER RESTRICTIONS (755.06)**

Glass bottles and cans are prohibited on the beach or swimming area. No coolers are allowed in the beach area.

## HOURS (701.01 & 749.02)

Park hours are from 8:00am to dark, except in campgrounds and areas where a special permit has been granted. Campground quiet hours are 11:00 pm and 7:00 am.

#### HUNTING (753.01)

Hunting, trapping and the molesting of wildlife is prohibited within the parks. Hunting is permitted only in specifically designated areas when first obtaining a SCPD hunting permit and hunting license and adhering to established rules and regulations.

## HUNTING & FISHING REGULATIONS (753.04)

All hunting and fishing rules and regulations established by the Ohio Department of Natural Resources must be followed.

## LITTERING (521.01)

Littering, dumping of garbage, sewage and noxious material is prohibited.

Garbage or other materials arising from normal picnic, camp, or other permitted activity shall be deposited in trash receptacles.

## NONREGISTERED VEHICLES (331.39)

Nonregistered motor vehicles may not be operated on any roadways within the parks.

## PARKING GENERAL REGULATIONS (351.01)

No person shall park or store any motor vehicle, bicycle, wagon, or other vehicle within any traveled roadway in the park or at a location where posted signs prohibit parking upon any sod, gravel, or other surface not specifically designated as a "parking area" except in an emergency before, during or after the posted park operating hours. All types of vehicles shall be parked within designated marked spaces where such spaces are provided.

#### PETS (505.01)

Pets must be kept on a leash or tether and not be left unattended.

## SCUBA DIVING (755.10)

Scuba diving is permitted only in those areas designated for that purpose and are subject to all the rules and regulations pertaining to that specific area.

#### **SMOKING AND VAPING (755.09)**

Smoking, vaping and chewing tobacco is prohibited on the beach or in any Park District buildings.

# SNORKELING (755.10)

Snorkeling is only permitted within designated swimming area when the beach is open with paid admission.

# SWIMMING (755.01)

Swimming and wading are permitted only at designated swimming areas and subject to all rules and regulations pertaining to that specific area.

# **UNMANNED AIRCRAFT (745.03)**

No drone or UAS are permitted unless a special use permit is obtained. All operators shall be in compliance with Federal Aviation's Unmanned Aircraft Systems Regulations and Policies.

# **UNSAFE FLOATATION OBJECTS (755.02)**

Only Coast Guard Approved Personal Floatation Devices allowed. No floaties, tubes, balls or "frisbees".

## WATERCRAFT IDENTIFICATION (381.23)

No person shall operate or permit to operate any watercraft on the waters in this Park District without a Hull Identification Number. **WATERCRAFT PROHIBITED MOTORS (381.23)** 

Only electric trolling motors shall be operated in the quarry.
